While on Guam, Andie and I visited with CEO James Oehlerking and new Human Resources Director Theresa Taimanglo. We shared our message and ideas about working together to help the members and company succeed together. One of the big challenges that IT&E face in Saipan, is the imminent competition from a subsidiary of one of Japan's largest mobile phone companies, DoCoMo Pa-

cific. DoCoMo Pacific has been laying miles of fiber in Saipan in preparation to offer telephone, internet and television services. IT&E has been the only provider in Saipan for many years and with a new player in town you can understand the apprehension. In order to start combating the threat, IT&E has ramped up its customer service training. While talking to the members in Chalan Laulau, and Susupe, they are all in agreement that the monthly training is extremely successful and long overdue

As we continue to march towards negotiations, it is important that we are all marching together in unity. Even though the end of our agreement is months away, the time to show the company that our IBEW members are the most qualified and best employees that they have is now. No outside entity can match our level of craftsmanship, customer service and dedication to our work as our members can. One of the main reasons that Hawaiian Telcom was able to get where it is today is because of its hard working and dedicated IBEW members. It is our members that sacrificed the most in order for Hawaiian Telcom to build its Next Gen network. Also during this time, our members have endured the company's mismanagement of the workforce, overly aggressive cuts in headcount, and working excessive amount of overtime with little or no regards for their well-being and family life along with heavy handed disciplines for those who cannot sacrifice their family time. Only by standing together in solidarity will we be able to continue to push our union in a successful direction. Please remember that every Friday is Union Friday and wear your logo apparel or blue to show our solidarity as we go full speed into negotiations.

INTERNATIONAL WORKERS DAY:

On May 1, 1886, Industrial workers across the U.S. go on strike, demanding an 8-hour workday. On May 4 in the city of Chicago, an unidentified person threw a bomb during a labor demonstration, leading to the injury and death of many nearby civilians. May 1 was than chosen to commemorate that 1886 incident known as the Hay-



market affair, and has been recognized as International Workers Day. This commendable day is also a traditional magnet for labor demonstrations to occur. More than 300,000 food chain employees and 40,000 service workers across America were expected to participate in a massive strike this year. Many unions participate in protest and understand the risks involved, however, they are willing to take that risk in order to continue to remind workers about the movement and what it stands for. Here in Hawaii, IBEW Local Union 1357 showed their support and solidarity by marching alongside with other sisters and brothers from various unions around the state who were supporting the same cause as well!



As we enter into contract negotiations I ask all of you no matter if you work in the office or in the field to work safely, give an honest day of work, don't deviate, and do quality work that our customers deserve. SAFETY CORNER



As Chief Shop Steward from Maui, I would like to share some pointers on making everyone's job, including the shop stewards and the union staff easier and safe. First in my opinion, at the start of your day, if your five minutes early, than your ten minutes late. You shouldn't rush to work but be in early enough to relax, and prepare readiness to work. If at all possible, NEVER be late! Second, don't deviate from your work duties. If you need to make any type of schedule changes, notify your supervisor immediately. Third, if you use company equipment such as, vehicles, tools, and computers, treat it with respect (as if it was your own) and just as importantly, use it for company use only. Fourth, your work ethics should be in line with the union's "Code of Excellence" policy. At the end of the day, you should be proud of your work. Fifth, if you're sick than you're sick! Use your sick leave appropriately and do not abuse this benefit as it should be used for that true purpose. Sixth, your safety

should always be first, no matter what. Injury or death is an unacceptable outcome especially when it's preventable. However, accidents do happen, hopefully few and far between, and your vigilance is required every day for a safe work day. Safety is not only for yourself, keep a watchful eye on your sisters and brothers who might put themselves in harm's way.

The IBEW Code of excellence puts in writing some common-sense values that helps us evaluate how we're doing and how we're responding to our customer's needs.


It is a document signed by our members before we report to your jobsite.

WHAT'S COOKING?

Moist Banana Bread with Walnuts

What you need:

1 egg

1-2/3 cups mashed fully ripe bananas (about 4)

1/2 cup Miracle Whip dressing

1-1/2 tsp. vanilla

1 cup sugar

1 tsp. baking soda

1-1/2 cups flour

1/2 cup coarsely chopped walnuts

Make it:

Heat oven to 350°F.

Mix egg, bananas, Miracle Whip and vanilla in large bowl until

hlended

Combine remaining ingredients in a separate bowl. Add banana mixture;


Stir just until moistened. (Batter will be lumpy)

Pour into 9x5 inch loaf pan sprayed with cooking spray.

Bake 1 hour or until toothpick inserted in center comes out clean. Cool in pan 10 minutes.

Remove to wire rack; cool completely.





Chocolate-Vanilla Swirl Cheesecake

What you need:

20 OREO Cookies, crushed (about 2 cups)

3 Tbsp. butter, melted

4 pkg. (8 oz. each) Philadelphia Cream Cheese, softened

1 cup sugar

1 tsp. vanilla

1 cup sour cream

4 eggs

11/2 pkg. (4 oz. each) Bakers Semi-Sweet Chocolate,

melted, cooled

Make it:

Heat oven 325°F.

Mix cookie crumbs and butter, press onto bottom of foillined 13x9 Inch pan. Bake for 10 minutes.

Beat cream cheese, sugar and vanilla in large bowl with mixer until well blended. Add sour cream; mix well. Add eggs, 1 at a time, mix.. Reserve 1 cup of batter.. Stir chocolate into remaining batter, pour over crust. Top with spoonful's of reserved batter. Swirl batter with knife. Bake 40 minutes or until center is almost set. Refrigerate 4 hrs Then enjoy!
